ADMINISTRATIVE ORDER**

By the authority vested in me as Administrative Judge of the Supreme Court, Civil Branch, New York County, in light of the Decision and Order of the Litigation Coordinating Panel in the matter of Kelly v. Pfizer, Inc., Panel No. 002/2005 (dated Nov. 30, 2005), and pursuant to Section 202.69 (c) (1) of the Uniform Rules for the Trial Courts, and in view of the fact that the Supreme Court, Civil Branch, New York County is establishing a Center for Complex Litigation in implementation of the recommendations of the Comprehensive Civil Justice Program - - 2005 and is assigning several Justices to said Center,

IT IS HEREBY ORDERED that the Administrative Order dated June 22, 2005 regarding assignments of Celebrex and Bextra litigations is hereby superceded and the assignments set forth therein are recalled, and it is further

ORDERED that all cases seeking damages for personal injury from ingestion of the drug Bextra only that are currently pending in the Supreme Court, Civil Branch, New York County or that shall hereafter be commenced in this County shall be assigned to Hon. Shirley W. Kornreich, one of the Justices of the Center, for the purpose of coordination as set forth below and for all other purposes, and it is further


ORDERED that Justice Kornreich is hereby designated as the Coordinating Justice for the coordination directed by the Panel in the aforesaid Decision and Order, and it is further

ORDERED that (i) all pending cases seeking damages for personal injury from ingestion of the drug Bextra only that are listed in the Decision and Order of the Panel, and any other pending cases of this type that are not so listed but are pending in this County or that, pursuant to the Decision and Order, shall be transferred to this County for inclusion in the coordination, and (ii) any such cases that shall be commenced hereafter either in this County or that, pursuant to the Decision and Order, shall be transferred to this County for

inclusion in the coordination shall be assigned to Justice Kornreich for the purpose of, and shall be included in, the coordination, and it is further

ORDERED that attorneys hereafter filing any such matters in this court or effecting transfer of any such matters to this court pursuant to the said Decision and Order shall attach to the Request for Judicial Intervention a copy of this Administrative Order.
