2. Include a copy of the front of the ticket(s) and an Abstract of your Drivers License from DMV.
3. A self-addressed stamped envelope must accompany your request. Your request will not be processed without it.
4. Please read the form carefully and sign the waiver at the bottom. If this form is not signed, it will not be processed.

ANY AGREEMENT MADE WITH THE DISTRICT ATTORNEY'S OFFICE IS SUBJECT TO APPROVAL OF THE COURT. A CASE IS NOT DISPOSED UNTIL YOU RECEIVE A RECEIPT FROM THE COURT. ANY REQUESTS FOR ADDITIONAL TIME MUST BE MADE THROUGH THE COURT.
