Under the supervision of New York State Senior Court Attendants, Appellate Division, New York State Court Attendants, Appellate Division are responsible for maintaining order and decorum in courthouses, court buildings and grounds. They also perform various clerical, reception, messenger and other related duties. New York State Court Attendants, Appellate Division are peace officers, required to wear uniforms, and may be authorized to carry firearms.

ASSIGNMENT:

Typical duties of a New York State Court Attendant in the Appellate Division include but are not limited to the following: Physically restrains unruly individuals; ensures that courtroom is prepared for court proceedings; responds to requests from lawyers and the public for general information and directs visitors to locations in the courthouse; delivers and retrieves case folders, law books, documents, and other materials; operates security equipment, including magnetometers, handheld screening devices and x-ray machines; uses established search procedures to ensure that no weapons or electronic or photographic equipment are brought into the courtroom; drives Judges to official functions throughout the Department.

The above statements are intended to describe the general nature and level of work being performed by persons assigned to this title. They do not include all job duties performed by employees in the title, and every position does not necessarily require these duties.
