

**TAMPERING WITH A WITNESS  
FIRST DEGREE  
(B Felony)  
(Causing Serious Injury to Witness Before Testimony)  
PENAL LAW § 215.13(1)  
(Committed on or after Sept. 1, 1982)**

The \_\_\_\_\_ count is Tampering with a Witness in the First Degree.

Under our law, a person is guilty of Tampering with a Witness in the First Degree when he or she intentionally causes serious physical injury to a person for the purpose of obstructing, delaying, preventing or impeding the giving of testimony in a criminal proceeding by such person or another person or for the purpose of compelling such person or another person to swear falsely.

Some of the terms used in this definition have their own special meaning in our law. I will now give you the meaning of the following terms: "criminal proceeding," "serious physical injury" and "intentionally."

**CRIMINAL PROCEEDING** means any proceeding which (a) constitutes a part of a criminal action or (b) occurs in a criminal court and is related to a prospective, pending or completed criminal action, either of this state or of any other jurisdiction, or involves a criminal investigation.<sup>1</sup>

**SERIOUS PHYSICAL INJURY** means impairment of a person's physical condition which creates a substantial risk of death or which causes death or serious and protracted disfigurement, protracted impairment of health or protracted loss

or impairment of the function of any bodily organ.<sup>2</sup>

Intent means conscious objective or purpose. Thus, a person INTENTIONALLY causes serious physical injury to a person when that person's conscious objective or purpose is to do so.<sup>3</sup>

In order for you to find the defendant guilty of this crime, the People are required to prove, from all the evidence in the case, beyond a reasonable doubt, both of the following elements:

1. That on or about (date), in the county of (county), the defendant, (defendant's name), intentionally caused serious physical injury to (specify); and
2. That the defendant did so for the purpose of obstructing, delaying, preventing or impeding the giving of testimony in a criminal proceeding by such person or another person, or for the purpose of compelling such person or another person to swear falsely.

Therefore, if you find that the People have proven beyond a reasonable doubt both of those elements, you must find the defendant guilty of the crime of Tampering with a Witness in the First Degree as charged in the \_\_\_\_\_ count.

On the other hand, if you find that the People have not proven beyond a reasonable doubt either one or both of those elements, you must find the defendant not guilty of the crime of Tampering with a Witness in the First Degree as charged in the \_\_\_\_\_ count.
