1. Law Guardians are to be assigned on a ROTATIONAL BASIS---
DO NOT SKIP ANY NAMES.
2. At the beginning of the term, it is the responsibility of each part to insure that the starting position is at the point where the last selection was made for the previous term.
3. When contacting the law guardian for assignment and you reach an answering machine, DO NOT HANG UP, leave a message and request that your call be returned as soon as possible or within a specified period of time. If the call is not returned, indicate in the column 'UNABLE TO CONTACT'--left message--no response and proceed to the next name.
4. EMERGENCY CASES--You may assign the most available attorney if you need a law guardian immediately and use an 'E' to indicate emergency assignment.
5. REMINDER--all attorneys contacted during the current term must have a comment in one of the columns---ABSOLUTELY NO BLANKS, unless the attorney has requested not to be assigned to a particular location.
