
Administrative Order:

By letter dated June 7, 2016, counsel for respondent Joseph Sedgh timely requests that this special proceeding, and two related special proceedings, Matter of David Sedgh v Joseph Sedgh (Index No. 652743/16) and Matter of Jacob Sedgh, et al. v Joseph Sedgh (Index No. 652744/16), be transferred into the Commercial Division pursuant to the Rules of the Commercial Division, Uniform Rule 202.70 (e). To date, no objection to the request has been received.

Proceedings seeking the "dissolution of corporations, partnerships, limited liability companies, limited liability partnerships, and joint ventures" will be heard in the Commercial Division "without consideration of the monetary threshold" (Uniform Rule 202.70 [b] [11]). In this special proceeding, petitioners seek the judicial dissolution of 379 West 125th Street, LLC. In Matter of David Sedgh v Joseph Sedgh, Index No. 652743/16, petitioner seeks the dissolution of David & Joseph Realty, LLC. In Matter of Jacob Sedgh, et al. v Joseph Sedgh, Index No. 652744/16, petitioners seek the dissolution of Sedgh Realty LLC. Thus, all three proceedings meet the standards for assignment to the Commercial Division under Uniform Rule 202.70 (b) (11).

Accordingly, the request for a transfer to the Commercial Division is granted. The General Clerk's Office is directed to randomly reassign this case and the alleged related actions, Matter of David Sedgh v Joseph Sedgh (Index No. 652743/16) and Matter of Jacob Sedgh, et al. v Joseph Sedgh (Index No. 652744/16), to the same Justice of the Commercial Division.
