Master File

1. The court hereby directs that a master file, known as Part 60 RMBS Put-Back Litigation, Index No. , (Master File) shall be established, without fee, in the Office of the Clerk of New York County for the RMBS Put-Back actions for: a) all RMBS Put-Back actions identified on Schedule A hereto (representing all actions in which the parties have agreed to coordinate the litigation – e.g., to coordinate discovery and to enter into a Case Management Order or Orders) (Stipulated Coordination Action[s]); and b) all RMBS Put-Back actions hereafter assigned to this court (Part 60), whether or not the parties have agreed to such coordination (Subsequently Filed Put-Back Action[s]) (Categories [a] and [b] are collectively referred to as the “RMBS Put-Back Actions”); and

2. A separate file shall also continue to be maintained in the Office of the Clerk of New York County under a separate Index Number for each individual RMBS Put-Back Action (Specific Case File).

3. Every document filed by a party in the RMBS Put-Back Actions shall bear the following caption (“Master Caption”):

If a document relates to all cases, the following will be added to the caption:

4. If a document applies to one or more specific cases but not to all cases, in addition to the Master Caption, one specific caption shall be included on the face of the document. Such specific caption shall be the caption for either 1) the lead movant, if the parties to the specific cases agree thereto; or 2) in the case of a motion, the caption for the case which first served the motion; or 3) for all other papers, the caption for the first filed of the specific cases to which the document applies. All of the other specific cases to which the document applies shall be listed as “Related Cases” in an appendix to the document, which shall be separately tabbed and easily identifiable by the Clerk of the Court.

5. If a document applies to an RMBS Put-Back Action, it shall be filed by the parties in the Master File. In addition, any document so filed shall be deemed to have been filed in each case to which this order applies and shall constitute part of the record of each case. Nothing herein shall prevent a party to a specific case from also filing a document which has been filed in the Master File in the Specific Case File. Provided that: With respect to any motion(s) that

relate solely to a specific action or actions, only the notice of motion shall be filed in the Master File. Any papers that relate solely to procedural matters in one or more specific actions (e.g. pro hac vice motions or stipulations, adjournments of motion briefing) shall be filed solely in the Specific Case File to which the papers relate. Any discovery stipulations or orders, even if related solely to a specific action, shall be filed in the Master File.

6. Any written decision, order, or other directive by the court will be filed, at the court's option, only in the Master File, and shall be deemed to have been filed in each case to which the decision, order, or directive applies and shall constitute part of the record in each case.

7. Two hard copies of each paper filed, whether in the Master File or the Specific Case File, shall be filed with the Clerk of Part 60.


8. A party shall not be deemed to have consented to coordination by virtue of its filing of a paper in the Master File.

9. This order shall apply to all documents in the Part 60 RMBS Put-Back Litigation, notwithstanding anything to the contrary in any other order in this Litigation.
