DEPARTMENT, PETITIONER.

Petitioner having moved for an order suspending the respondent attorneys named on the attached list for their failure to comply with attorney registration requirements in violation of Judiciary Law § 468-a and 22 NYCRR 118.1, and this Court, by order to show cause entered June 24, 2015, having directed respondents to file a written response on or before August 27, 2015, setting forth why an order should not be entered suspending them from the practice of law for their failure to comply with attorney registration requirements, and, respondents having failed to respond to the order or to comply with attorney registration requirements,

NOW, upon reading and filing the show cause order with proof of service thereof, and due deliberation having been had thereon,

This Court finds that respondents are guilty of professional misconduct, and

It is hereby **ORDERED** that the motion of petitioner is granted and respondents are suspended from the practice of law until further order of this Court, and

It is further **ORDERED** that respondents are hereby commanded for the period of the suspension to desist and refrain from the practice of law in any form, either as principals or agents, clerks or employees of another, and are hereby forbidden to appear as attorneys

or counselors at law before any court, judge, justice, board, commission or other public authority, or to give to another an opinion as to the law or its application, or any advice with relation thereto, and

It is further **ORDERED** that respondents shall comply with Rule 1022.27 of the rules of this Court (22 NYCRR 1022.27) governing the conduct of suspended attorneys, and

It is further **ORDERED** that respondents shall immediately surrender to the Office of Court Administration any secure pass issued to them and shall certify that they have done so in the affidavit of compliance filed pursuant to Rule 1022.27 (d) (22 NYCRR 1022.27 [d]), and

It is further **ORDERED** that petitioner shall serve the respondents with this order by: mailing a certified copy of the order to each of the respondents at the address provided to the Office of Court Administration by the respondents; publishing a certified copy of the order and the attached list in the New York Law Journal once each week for four consecutive weeks, commencing with the week of November 9, 2015, and ending with the week of November 30, 2015; and, posting a certified copy of this order and the attached list on the website maintained by this Court for a period of thirty (30) days, commencing November 2, 2015 and ending December 2, 2015.
