

PREDATORY SEXUAL ASSAULT
Penal Law § 130.95(2)
(Committed on or after June 23, 2006)

Under our law, a person is guilty of Predatory Sexual Assault when he or she commits the crime of

In order for you to find the defendant guilty of this crime, the People are required to prove, from all the evidence in the case, beyond a reasonable doubt, both of the following elements:

The Court may in lieu of the following element for each Sex Act substitute the elements of the applicable crime as set forth in the CJI2d charge for that crime.

[SEXUAL ACT I]

1. That on or about (date) , in the County of (County) , the defendant, (defendant's name) , committed (name of underlying crime, e.g., rape in the first degree) in that he/she (insert element(s) of underlying crime and complainant's name; e.g., in that he engaged in sexual intercourse with (complainant) by forcible compulsion) ; and

[SEXUAL ACT II]

2. That, on or about (date) , in the County of (County) , the defendant, (defendant's name) , committed (name of underlying crime, e.g. criminal sexual act in the first degree) in that he/she (insert element(s) of underlying crime and complainant's name; e.g., in that he engaged in oral sexual conduct with (complainant) by forcible compulsion)

If you find the People have proven beyond a reasonable doubt both of those elements, you must find the defendant guilty of this crime.

If you find the People have not proven beyond a reasonable doubt either one or both of those elements, you must find the defendant not guilty of this crime.
