AGGRAVATED IDENTITY THEFT (PENAL LAW 190.80-a) (Committed on or after Nov. 4, 2008)

The (specify) count is Aggravated Identity Theft.

Under our law, a person is guilty of Aggravated Identity Theft when he or she knowingly and with intent to defraud assumes the identity of another person

Select appropriate alternative(s):

by presenting himself/herself as that person [or] by acting as that person [or] by using personal identifying information of that person, ¹

and knows that such person is a member of the armed forces, presently deployed outside of the continental United States and

Select appropriate alternative:

thereby obtains goods, money, property or services or uses credit in the name of such member of the armed forces in an aggregate amount that exceeds five hundred dollars;

thereby causes financial loss to such member of the armed forces in an aggregate amount that exceeds five hundred dollars.

The following terms used in that definition have a special meaning:

A person KNOWINGLY assumes the identity of another person when that person is aware that he or she has assumed the identity of that other person.²

INTENT means conscious objective or purpose. Thus, a person acts with intent to defraud when his or her conscious objective or purpose is to do so.³

MEMBER OF THE ARMED FORCES means a person in the military service of the United States or the military service of the state, including but not limited to, the armed forces of the United States, the army national guard, the air national guard, the New York naval militia, the New York guard, and such additional forces as may be created by the federal or state government as authorized by law.⁴

[PERSONAL IDENTIFYING INFORMATION means a person's

electronic signature⁵, unique biometric data that is a fingerprint, voice print, retinal image or iris image of another person, telephone calling card number, mobile identification number or code, electronic serial number or personal identification number⁶, or any other name, number, code or information that may be used alone or in conjunction with other such information to assume the identity of another person.⁷]

In order for you to find the defendant guilty of this crime, the People are required to prove, from all the evidence in the case, beyond a reasonable doubt, each of the following four elements:

1. That on or about (<u>date</u>), in the County of (<u>county</u>), the defendant (<u>defendant's</u> <u>name</u>) assumed the identity of (<u>specify</u>)

- 3. That the defendant knew that (<u>specify</u>) was a member of the armed forces presently deployed outside of the continental United States; and
- 4. Select appropriate alternative(s):

That the defendant obtained goods, money, property or services or used credit in the name of (<u>specify</u>) in an aggregate amount that exceeded five hundred dollars, *or*

That the defendant caused financial loss to <u>(specify)</u> in an aggregate amount that exceeded five hundred dollars.

If you find the People have proven beyond a reasonable doubt each of those elements, you must find the defendant guilty of this crime.
