The (<u>specify</u>) count is Criminal Sale of a Controlled Substance in the Third Degree.

The revision was for the purpose of expanding the definition of the term "sell" as it applies to an offer or agreement to sell.

Under our law, a person is guilty of Criminal Sale of a Controlled Substance in the Third Degree when that person knowingly and unlawfully sells

Select the appropriate alternative:

a stimulant and the stimulant weighs one [1] gram or more.

lysergic acid diethylamide and the lysergic acid diethylamide weighs one [1] milligram or more.

a hallucinogen and the hallucinogen weighs twenty-five [25] milligrams or more.

a hallucinogenic substance and the hallucinogenic substance weighs one [1] gram or more.

phencyclidine and the phencyclidine weighs two hundred fifty [250] milligrams or more.

The following terms used in that definition have a special meaning:

[The term STIMULANT (or HALLUCINOGEN) (or HALLUCINOGENIC SUBSTANCE) includes (specify) .²]

SELL means to sell, exchange, give or dispose of to another.

[Sell also includes an offer or agreement to sell even if actual delivery does not occur, provided that, at the time of the offer or agreement, the person has the intent and ability to make the sale. An intent is a conscious objective or purpose. Thus, a person acts with intent to sell when that person's conscious

objective or purpose is to sell.]³

A person KNOWINGLY sells <u>(specify)</u> when that person is aware that he or she is selling <u>(specify)</u> .4

A person UNLAWFULLY sells <u>(specify)</u> when that person has no legal right to sell it.⁵ Under our law, with certain exceptions not applicable here, a person has no legal right to sell <u>(specify)</u>.

In order for you to find the defendant guilty of this crime, the People are required to prove, from all the evidence in the case, beyond a reasonable doubt, each of the following three elements:

- 1. That on or about <u>(date)</u>, in the county of <u>(county)</u>, the defendant, <u>(defendant's name)</u>, sold <u>(specify)</u>;
- That the defendant did so knowingly and unlawfully; and
- 3. That the <u>(specify)</u> weighed <u>(specify)</u> or more.

If you find the People have proven beyond a reasonable doubt each of those elements, you must find the defendant guilty of this crime.

If you find the People have not proven beyond a reasonable doubt any one or more of those elements, you must find the defendant not guilty of this crime.
