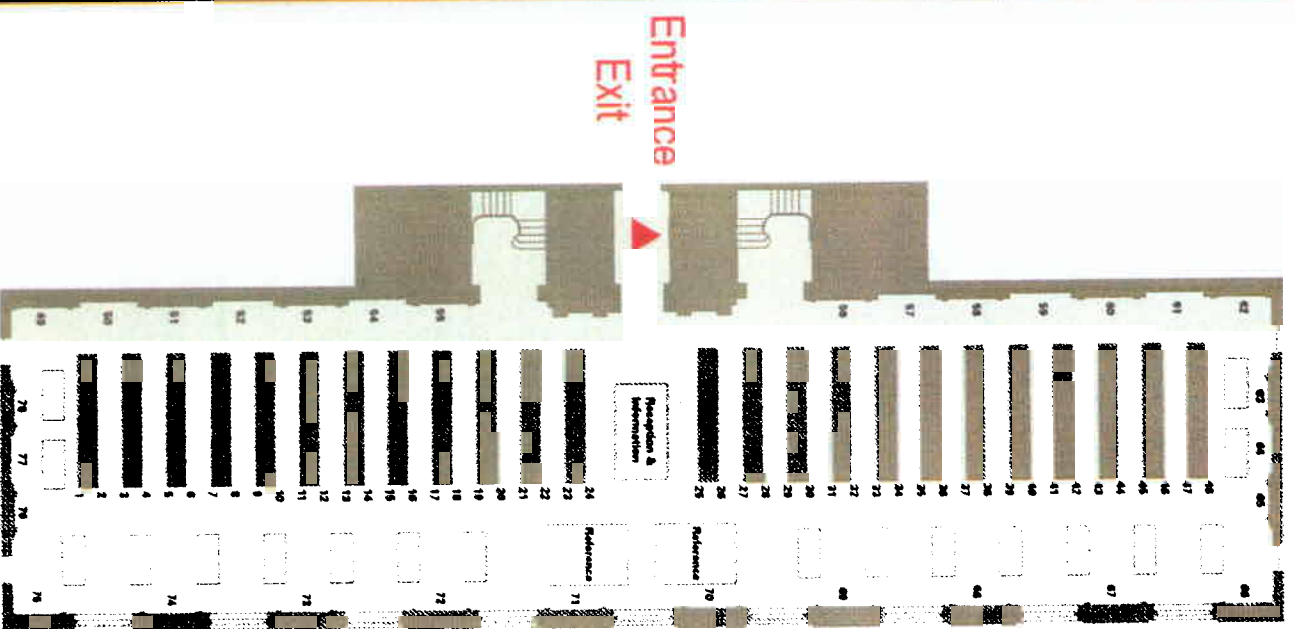
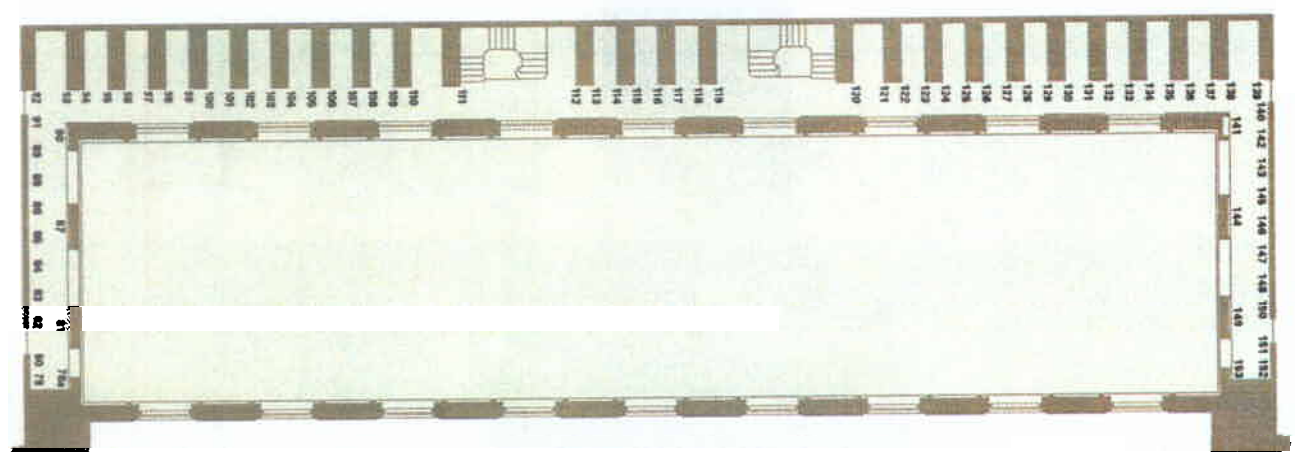

Mission Statement

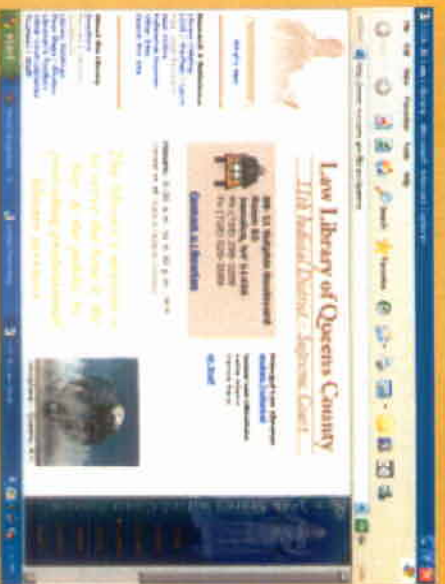
The Law Library is an important part of the Queens Supreme Court, supporting our judges and court personnel with legal research material and reference assistance.

Just as important, the Law Library serves the people of Queens County, providing access to information about the law and court procedures.

The Law Library is open to all, both attorneys and the wider non-legal community, as mandated by New York state law (N.Y. Jud. Law §§ 813 and 814)

Although the Law Library staff may not interpret the law or evaluate the relevance of a case or statute to a specific legal problem, the Library staff may help locate sources of information and suggest search strategies to assist attorneys and non-attorney patrons.

Borrowing privileges are limited to judges and authorized court personnel.



The Law Library's online catalog "LION" can be searched from your courthouse, office, or home PC. To search the catalog go to the Law Library's website www.nycourts.gov/library/queens and click the Library Catalog link in the upper left of the home page.

Print Collection

The Law Library contains an extensive print collection. The main focus is on New York state and local (New York City) law, including cases, statutes, finding aids, rules and regulations, and many treatises on specific areas of New York law and practice. The Library includes historical New York legal materials (i.e. superseded codes and rules, reports of many state commissions, previous editions of landmark legal treatises).

In addition, the Library maintains a complete print collection of federal case reporters, statutes, regulations, all superseded federal annotated statute volumes, many federal practice treatises and the current statutes of many states.

The Library holds a large collection of current treatises on a wide variety of legal topics.

NY appellate records and briefs are available.



Electronic Resources

The Law Library provides Internet access at four computers including access to Lexis and Westlaw. In addition, there are two computers dedicated to the Unified Court System's "CourtHelp" website. CourtHelp provides free access to frequently used forms and answers to frequently asked questions about New York law and legal procedure.
