Exit 37 - turn right and proceed East on Route 3 approximately 2 miles; Route 3 (Cornelia Street) splits as you past McDonald's, stay in left hand lane, proceed straight on Cornelia; past Hospital on left, past College on right, past fire station on right, the next block is a 3 story red brick building, take a right on Margaret Street, take next right on Court Street and turn in to parking lot.

Exit 38 South - proceed straight on North Catherine Street (1 way street), stay in left hand lane, at intersection with Cornelia Street take a left on to Cornelia Street (St. Peter's Church is on your left at the intersection), go straight (East) on Cornelia, past fire station on right, the next block is a 3 story red brick building, take a right on Margaret Street, take next right on Court Street and turn in to parking lot.

Bear left at the next Y intersection onto U.S. Ave. Follow roundabout and bear right onto New York Road. At the first stop sign turn left onto Ohio Avenue. At the next stop sign turn right onto U.S. Oval. The end of the first building is 24 U.S. Oval.
