**parking:**

General parking and parking for the disabled are  
located around the building.

**ADA accessibility:**

The public entrance to the Court Wing of the  
Municipal Center is located at the far north end of  
the building. The public entrance, as well as the  
bathrooms within the Court Wing, are handicap  
accessible.

**security:**

The public entrance to the Court Wing is equipped  
with a magnetometer through which visitors and  
courts users must pass.

**directions:**

We are located off Exit 20 of the Adirondack  
Northway (I-87).

**From the South:** Turn right at the light and follow  
Route 9 southbound to the first light. Turn left into  
the Municipal Center parking lot.

**From the North:** Turn left at the end of the off  
ramp and follow through the traffic light into the  
Municipal Center parking lot.

**transportation:**

The Greater Glens Falls City Transit Bus service  
stops directly in front of the main entrance to the  
municipal center.
