Implementation of Mandatory Electronic Filing in Allegany, Cattaraugus, Genesee, Niagara, Orleans and Wyoming Counties Surrogate's Courts

I am pleased to provide the Bar and other interested persons with an update on the progress of the New York State Courts' Electronic Filing System ("NYSCEF"). The implementation of mandatory e-filing programs has been proposed by the District Administrative Judge of the 8th Judicial District for Allegany, Cattaraugus, Genesee, Niagara, Orleans and Wyoming Counties Surrogate's Courts to take effect May 23, 2018. To date, consensual e-filing programs have been successfully implemented in these courts. As of the effective date, the authorization will implement a mandatory e-filing program for newly filed probate and administration proceedings and miscellaneous proceedings relating thereto.

The District Administrative Judge of the 8<sup>th</sup> Judicial District additionally proposes to modify the existing consensual e-filing in Allegany, Cattaraugus, Genesee, Niagara, Orleans and Wyoming Counties Surrogate's Courts to include such other types of proceedings as the court may permit.

Persons wishing to comment on this proposal should e-mail their submissions to <u>efilingcomments@nycourts.gov</u> no later than May 16, 2018. A new page has been created on the Unified Court System's website - <u>www.nycourts.gov/rules/efiling/</u> - to provide notice to the public of proposed new or expanded mandatory e-filing programs and for posting any public comments received on such proposals. As we move forward with implementation of mandatory e-filing in Allegany, Cattaraugus, Genesce, Niagara, Orleans and Wyoming Counties Surrogate's Courts, please be assured that we will continue to offer training prior to and after the effective date. The NYSCEF system is intuitive and easy to use, and the training program takes about two hours to complete. Training will be offered by staff of the E-Filing Resource Center both on-line and onsite.

Wednesday, April 18, 2018, 2:00 PM – 4:00 PM, Genesee County Courts Facility, 1 W. Main Street, Jury Assembly Room, 2<sup>nd</sup> floor, Batavia, New York 14020.

Attorneys participating in an on-site session receive two CLE credits free of charge. Attorneys, paralegals and interested parties may go to the NYSCEF website to register on-line for the upcoming training sessions.

Please note that Chapter 237 continues to provide an opt-out mechanism in mandatory effling cases for those attorneys who certify in good faith that they lack the requisite hardware, electronic connection or technical knowledge to participate in e-filing. However, Chapter 237 has changed the law so that unrepresented litigants are now automatically exempt from participating in e-filing and are no longer required to opt out. Unrepresented litigants may however choose to participate in e-filing. E-filing represents an important advance for the courts and the legal profession in New York State.
