# **Purpose of Guide**

This guide will show you how to schedule your appointment using the self-scheduling link received via email. It will also show you how to reschedule and/or cancel your appointment, if needed.

# How to Schedule an Appointment

- 1. In your invite email (Figure 1) there is a link that will allow you to self-schedule your appointment for the Court Officer Trainee Exam.
- 2. Click on the link to start the process.
- 3. Take note of the "Applicant ID" value as you will need that number in the next step of the process.

#### Identification

You need to arrive at the test center fifteen (15) minutes prior to the beginning of your test appointment to allow time for the check-in process. If you are more than fifteen (15) minutes late for your scheduled appointment, you may not be permitted to test. Please be sure to take care of any personal needs before appointment check-in.

Upon arrival, you will be required to present one official, valid piece of identification that meets the following requirements:

- The ID must be issued by Federal or State Government and must be a Driver's License, U.S. State Issued ID Card, U.S. Passport, U.S. Military ID, U.S. Resident Card/Green Card, U.S. Employment Authorization/Document, U.S. Government issued Visa, U.S. Territory ID (Puerto Rico, Guam, etc.).
- Student IDs are also acceptable.
- The ID must bear a PHOTO.
- The ID must be original. No photocopies or faxes will be accepted.
- The ID must also be current (non-expired) and legible.
- The ID must contain an identical name when compared with the name listed on this scheduling site. If you need to make a change, please do so now by accessing your Profile and editing your personal information.

If you arrive at the test center without an ID that meets the above requirements, you will not be permitted to test. If appropriate, you should also bring your login

- 1. Next you will be allowed to indicate where you want to test and a date range to review test center availability.
- 2. Enter the city and state of either your residence or a zip code close to where you want to schedule your appointment.
- 3. By default, a 2-week window is selected for the range of dates you want to search. Adjust this time by selecting a new date on the calendar after clicking on the date field.
- 4. Click the "Search" button. This will show you available times for your appointment.
- 5. Click on the button that has the time of the appointment you wish to select.



- 1. Next you will be asked to confirm your appointment.
- 2. The confirmation requires your phone number in case you need to be contacted for rescheduling.
- 3. Click "Schedule Appointment" when ready to complete your transaction.

#### **Check Center Closures**

As a candidate, you are responsible for checking this link prior to leaving for your appointment to verify that your center has not been closed (inclement weather or other issues).

Plan on being at the test site for **four (4) hours** which includes check-in, set-up tasks and examination. The actual examination time is three hours and 15 minutes which includes the memory portion at the beginning of the examination.

**Cancel/Reschedule:** You may reschedule (subject to availability) or cancel up to **24 hours before** your appointment. It is your responsibility to cancel or reschedule your appointment. Do not contact the test center to cancel or reschedule as they do not have the ability to assist. You can cancel or reschedule by clicking on the below link. You are not able to cancel or reschedule once you are within the 24-hour window before your appointment.

- Personal Items: Please do not bring any unnecessary personal items to your assessment appointment. Your scheduled test center will have limited storage space for any personal items such as jackets and purses, but no personal items are allowed in the testing room. Items prohibited from the testing room include, but are not limited to: computer discs, electronic devices, firearms, knives, weapons, purses, briefcases, backpacks, books, reading material, calculators, notebooks, cell phones, pagers, umbrellas, pencils, pens, erasers, watches, smart watches, wallets, Google glasses, jackets, outerwear, sweaters, hoodies, hats, scarves, etc. Applicants who violate this policy will be disqualified from the test and not permitted to reschedule. We also ask that you do not have anyone accompany you into the test center as there is not adequate space for visitors.
- Cheating: Cheating is prohibited during all Proctored Assessments. Any attempt to copy and/or distribute
  test information, and/or attempt to get test answers from the internet, software programs, hard copy
  materials, other test takers, etc. is strictly prohibited. Applicants who violate this policy will be disqualified
  from the test and not permitted to reschedule.
- Breach in Policy: It will be considered a breach in testing policy if you possess any documents and/or
  electronic devices (including cell phones) or access a non-testing website while inside the testing room. Any
  breach in testing policies may result in your immediate dismissal. Your test materials will be collected, you
  will not be permitted to complete your exam, and you will be instructed to leave the test center at that time.
  Applicants who violate this policy will be disqualified from the test and not permitted to reschedule. In
  addition, applicants who attempt to copy and/or distribute test information may be criminally prosecuted.
- Test Center Closures: You are responsible for verifying that your test center has not been closed due to
