Proposed amendment of Request for Judicial Intervention Addendum in


foreclosure actions (UCS-840F), relating to addition of the mortgage servicer's

name.

A number of stakeholders involved in mortgage foreclosure cases, including judges and court staff, have suggested that it would be helpful to amend the Request for Judicial Intervention ("RJI") Addendum in foreclosure actions (UCS-840F) to identify the mortgage servicer involved in each case. Identifying the mortgage servicer would enable the court to search for cases by servicer and facilitate the scheduling of matters in mortgage foreclosure parts. A copy of the proposed form is attached as Exhibit A. The current form is attached as Exhibit B.
