Amendment # 1 to Request for Proposals # DPCS 150: Motivational Interviewing Training Services for New York State Drug Treatment Courts

Clarification of Minimum Qualifications

The New York State Unified Court System, Office of Court Administration ("OCA") is issuing this Amendment # 1 to modify: (i) the minimum qualification set forth in Article IV (Minimum Qualifications) of the above-referenced request for proposals ("RFP"); (ii) the Document Enclosure Checklist set forth in Exhibit 1; and (iii) the due date for proposals. OCA is amending the RFP specifications as follows (deletions appear in strikethrough text; additions appear in underlined text).

<u>1.</u> Modification of Minimum Qualifications

Article IV of the RFP is modified to accept proposals from bidders that commit to supply one or more MINT trainers as follows:

IV. MINIMUM QUALIFICATIONS

Proposals will be considered only from applicants who meet the following qualifications:

• Applicants must <u>either: (i)</u> be a Motivational Interviewing Network of Trainers (MINT) member, and proof of membership must be submitted to be considered for an award; or (ii) commit to supply one or more MINT trainers to conduct the trainings, and applicant's proposal must include a statement memorializing such commitment.

2. Modification of Exhibit 1 (Document Enclosure Checklist)

Exhibit 1 has also been modified to add the following item to the Document Enclosure Checklist:

<u>Proof of applicant's MINT membership or statement memorializing applicant's</u>
 <u>commitment to supply one or more MINT trainers to conduct trainings (Article IV)</u>

3. <u>New Due Date for Proposals</u>
