

Dashboard Overview

Purpose & Relevant Law Change

[Judiciary Law § 212 \(2\) \(u-1\) and \(v-1\)](#), requires the Unified Court System (UCS) to compile and publish data on misdemeanors and violations. In response to the new legislation and recommendations by the [Equal Justice in the NYS Courts](#) Committee to include felonies, the downloadable data extracts for [NYC](#) & [Outside NYC](#) of arraignments held statewide was published in November 2020 and is updated monthly.

In compliance with the law to provide aggregate incoming cases by county, the dashboard includes an aggregated, downloadable table for each requested piece of data in the legislation.

Dashboard Tutorial

Navigating the Dashboard

Two buttons at the top of each page are available to help with the dashboard experience.

1. **Dashboard Info & Navigation** – opens the [Info](#) page of the dashboard, which includes:
 - a. **Navigation Pane** links to all pages with a brief description of each page. Hover over the page name to get a more detailed description.
 - b. **Dashboard Overview** brief description of *Purpose & Data*
 - c. **Important Links** include:

Filters

The **Filters** pane is opened by selecting the **Page Info & Filters** button at the top of the dashboard. There are 10 filters that filter on 17 different fields. To clear a filter, select the erasure on the top right corner.

- i. **Year, Month** of Arraignment
- ii. **Region, District, & County** of the case
- iii. **Court Type & Arrest Type** (*Local*: Custody, DAT, NYC Summons; *Supreme/County*: unknown)
- iv. **Case Status & Dispo Type** (*Disposed*: Disposition Types; *Pending*: Not Disposed; *Warrant/Toll*: Not Disposed)
Top Charge at Arraignment
- v. **Severity & Weight** (*Felony*: AF, BF, CF, DF, EF; *Misdemeanor*: AM, BM, UM; *Violation*: V)
- vi. **Law & Article.Section** (example: Law = PL and Article.Section = 100.05)
Demographics
- vii. **Ethnicity** (*Hispanic, Non-Hispanic, Unknown*)
- viii. **Race** (*Black, White, Asian, Indian, Other, Unknown*)
- ix. **Gender** (*Female, Male, Unknown*)
- x. **Age Bracket** (*Under 18, 18-29, 30-39, 40-49, 50 & Over, Unknown*)

Any category label (i.e. *District 3, Misdemeanors, 2021-6*) can be used to filter the current page. *Easy Filters* in the **Page Info** pane gives hints on how to use the category labels to quickly filter the page without having to open the **Filters** pane.

Bonus Filters for court staff – There is a Filter Pane to the right of the dashboard with over 20 fields, plus additional filters specific to certain pages. View the count of arraignments for each category in the fields.

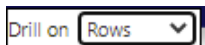

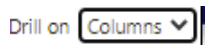

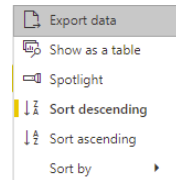

Additional options are available by *right-clicking* on a graph:

1. **Show as a Table** open graph in a larger window with the numbers below in table format

Use Include/Exclude to select only specific category(s) of a graph. Use *CTRL* to select multiple categories. Hit *Refresh* in the browser to go back to all categories.

2. **Exclude** when you want to *view* most of the categories
3. **Include** when you want to *exclude* most of the categories

When a graph with multiple layers (blue buttons on top) is expanded in a new window, the buttons are not available, but you can use the options below.

4. **Show Next Level/Drill Down**  shows an additional level of data
 - a. The graphs on the pages below go from [District](#) to [County](#). To view only counties in a specific district, select the District bar, *right-click* and select Drill Down.

6. **Drill Up**  goes back up a level

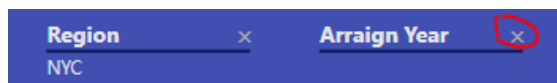

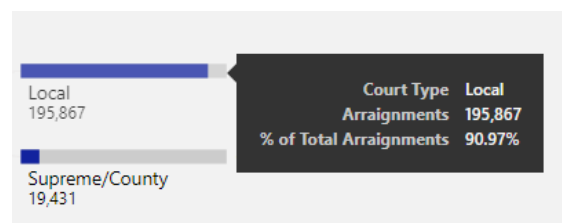
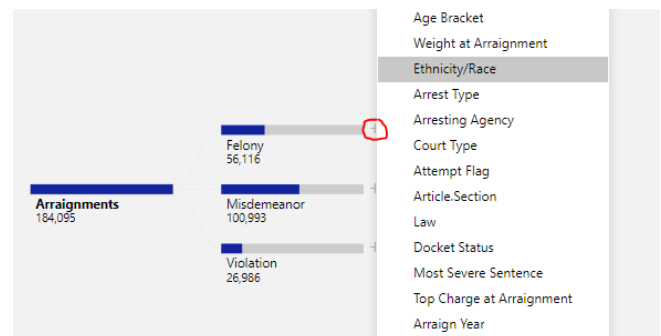
