ADMINISTRATIVE ORDER

Recently, the undersigned was advised by court staff that a number of what appeared to be related cases had been filed. These cases alleged damages due to personal injury suffered by students at a particular school, P.S. 132 located at 185 Wadsworth Avenue, New York, in or about May 2004. The cases had been assigned to all three City Part Justices.

I have examined the complaints in these cases and they do indeed seem to assert claims arising out of a single incident at one school. It would be in the interests of the parties and the court, conserve judicial resources, and avoid the risk of inconsistent rulings if all of these cases were to be assigned to a single City Part Justice. Furthermore, it appears that it would be beneficial for all parties and the court if these cases were to proceed as electronically-filed matters.


Accordingly, by the authority conferred upon me as Administrative Judge, I hereby direct the Trial Support Office (Room 158) to transfer to Part 52 (Hon. Matthew Cooper) all of the cases on the annexed list that are not already pending in that Part. Part 52 is the City Electronic Filing Part.

The annexed list consists of a copy of a notice of motion to consolidate 23 cases that apparently all arise out of the incident at the school. This motion has not yet been decided and should be transferred to Justice Cooper together with the cases for such action as appears appropriate to him.

Should a Request for Judicial Intervention be filed hereafter in any actions that have already been commenced in this court but that do not appear on the attached list, or that may be instituted hereafter in this court, and that allege personal injuries arising out of the claimed incident at the school, the filer shall identify the case as related to those covered by this order and annex to the RJJ a copy of this order.

Counsel for the parties in these cases should, at their earliest convenience, contact the Statewide Coordinator for Electronic Filing, Mr. Jeffrey Carucci, or his deputy, Mr. Christopher Gibson, at 646-386-3033 or efile@courts.state.ny.us. The E Filing Resource Center for New York State is located in Room 119 A in our courthouse at 60 Centre Street. Should counsel not already have E-Filing ID's and Passwords, Mr. Carucci, Mr. Gibson or Center staff can assist counsel to obtain them very promptly and can provide any other information needed so that counsel can proceed with electronic filing in these cases with ease and efficiency.
