

WHEREFORE defendant, Morse Diesel, Inc., requests summary judgment in the aboveentitled action, pursuant to Civil Practice Law and Rules 3212, dismissing the complaint and crossclaims against Morse Diesel, Inc., with prejudice, and after notice to all co-defendants there is no opposition, it is

ORDERED that upon notice to all co-defendants, all claims and cross claims against defendant Morse Diesel, Inc., are dismissed with prejudice and without costs.
