For referrals made to a Court Roster Neutral, the Court Roster Neutral shall provide 120 minutes of ADR services for free (60 minutes of which may be spent in preparation time and at least 60 minutes of which must be spent in the first ADR session); If the parties and Court Roster Neutral agree to continue beyond the free 120 minutes, the Court Roster Neutral may charge the fee published in the Roster of Neutrals (provided such fee has been disclosed to the parties in writing and in advance of the first ADR session); All ADR costs shall be shared equally by the parties unless otherwise directed by the Court or as agreed in writing by the parties; and it is further
