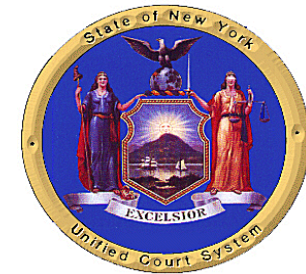

## What is the Court Help Center?

The Eighth Judicial District Court Help Center employs staff to provide free procedural information to the public. They are neutral parties who **cannot give legal advice** or tell you the best way to handle your case.

Help Center Staff CAN provide information:

- on how to commence cases
- on how to answer cases
- on how to collect judgments
- on filling out forms
- on court procedure
- on small claims cases
- on referrals to appropriate agencies
- on public access computer use
- on how to find your destination court

Help Center Staff CAN NOT:

- give legal advice
- provide information that should be entered on your form
- interpret statutes, cases, or opinions
- provide opinions about a judge, court employee or private attorney

## Who is the Court Help Center for?

The Help Center is available to anyone who needs assistance:

- to navigate the complex court system
- in obtaining legal information or legal forms
- and use of a word processor for preparing documents
- in finding out the status of a case

## What materials are available at the Help Center ?

The Help Center will have a variety of written material and sample forms available on topics involving Civil , Supreme and County Courts including:

- Uncontested Divorces
- Name Changes
- Courts of New York
- Child Support Determining the Amount
- Small Claims

## Does the Help Center have computers?
