By letter dated October 9, 2018, counsel for defendant Citigroup, Inc., on behalf of defendants, requests that this action be transferred into the Commercial Division pursuant to Commercial Division Rule 202.70. Counsel advises the court that plaintiffs do not oppose the transfer.

This action was commenced in 2008 under seal pursuant to the New York False Claims Act (N.Y. State Finance Law §§ 189, et seq.). At some point, the case was assigned to a non-commercial part (D'Auguste, J.). On May 29, 2018, Judge D'Auguste partially lifted the seal. Defendants were served with the complaint on or about September 17-18, 2018.

Although the Request for Judicial Intervention may have been filed years ago, the court deems the application timely under the circumstances presented (see Commercial Division Rule 202.70 [e]). The request is granted since the plaintiff's claims meet the monetary threshold and are premised upon allegations of fraud arising out of business dealings as well as alleged business transactions involving or arising out of dealings with commercial banks and other financial institutions. Thus, the standards for assignment to the Commercial Division in New York County are satisfied (see Commercial Division Rule 202.70 [a], [b] [1] and [6]).
