## DEPARTMENT OF EMPLOYMENT

By the power vested in me as Mayor of the City of New York it is hereby ordered as follows:

Section 1. Continuation of Department; Commissioner. There is continued in the Executive Office of the Mayor a Department of Employment ("Department"). The head of the Department shall be Commissioner of Employment, who shall be appointed by the Mayor and who shall serve at the Mayor's pleasure.

Section 2. Deputy. The Commissioner may appoint and at pleasure remove a deputy commissioner.

Section 3. Powers and duties. The Department shall have the following power and duties:

- to administer employment and training programs for unemployed, underemployed and economically disadvantaged youth and adults;
- to disburse available city, state and federal funds to employment and training programs throughout the city and, when practical, coordinate such funds with available funds from the private sector;
- to advise and assist the Mayor in developing policies designed to meet the needs of the unemployed and economically disadvantaged;
- d. to make such studies and reports regarding needs of the unemployed and economically disadvantaged as the Commissioner may deem appropriate or as may be requested by the Mayor;
- e. to maintain, operate and control such programs and facilities as may be necessary or required for the proper administration of the Department.

Section 4. Effective Date. This order shall take effect immediately.
