

Upon the foregoing papers, it is ordered that this Petition is determined as follows:

Aggrieved Petitioner-Candidate Joseph J. Chou's application for an Order declaring the subject Designating Petition valid, proper, sufficient, and legally effective, directing, requiring, and commanding Respondent BOARD OF ELECTIONS to print and/or place Petitioner's name as candidate for the Public Office of Representative in Congress from the 6th Congressional District, New York State in the Republican Primary Election to be held on June 25, 2024 and on all of the official ballots to be used at the Republican Primary Election to be held on June 25, 2024, and enjoining and restraining Respondent BOARD OF ELECTIONS from printing, issuing, or distributing any and all official ballots used in the subject election upon which Petitioner's name does not appear as a candidate for the Public Office of Representative in Congress from the 6th Congressional District, New York State is denied.

Aggrieved Petitioner-Candidate Joseph J. Chou commenced this proceeding pursuant to Election Law §16-102 to validate a petition designating him as a candidate in the Republican Primary Election on June 25, 2024. Based upon the Petition, the Board of Elections issued a determination removing Petitioner from the ballot. Petition commenced this proceeding thereafter and presents the Clerk's Report, Exception Report, and pages of the Designating Petition is support of his application.

A validating petition must specify the individual determinations of a Board of Elections that the candidate claims were erroneous, including the signatures that the candidate claims were improperly invalidated. (*Matter of Wagner v. Elasser*, 194 A.D.3d 891, 892 [2d Dept. 2021].) Here, the Validating Petition was not sufficiently particularized to give the Court and parties notice of which determinations were allegedly erroneous or which signatures Petitioner-Candidate claimed were improperly invalidated.

Accordingly, Aggrieved Petitioner-Candidate Joseph J. Chou's application for an Order declaring the subject Designating Petition valid, proper, sufficient, and legally effective, directing, requiring, and commanding Respondent BOARD OF ELECTIONS to print and/or place

Petitioner's name as candidate for the Public Office of Representative in Congress from the 6th Congressional District, New York State in the Republican Primary Election to be held on June 25, 2024 and on all of the official ballots to be used at the Republican Primary Election to be held on June 25, 2024, and enjoining and restraining Respondent BOARD OF ELECTIONS from printing, issuing, or distributing any and all official ballots used in the subject election upon which Petitioner's name does not appear as a candidate for the Public Office of Representative in Congress from the 6th Congressional District, New York State is denied. The Petition is hereby dismissed.

This constitutes the decision and Order of the Court.
