II. RFP # OCA/JB-120

Purpose and Scope

The UCS/OCA, on behalf of the JBO, is soliciting sealed bids/proposals to establish a single, estimated quantity term contract for the provision of a Fully Insured Term Life Policy for its Retirement-Eligible Judges. This would be a new and optional benefit for this group of judges and therefore, there is no claims experience available.

Estimated Quantities

Any quantity specified in this RFB/RFP constitutes an **estimate only** and accordingly, **no commitment or guarantee to reach any specified volume of business is made or implied.** Accordingly, the award shall be for an **estimated quantity term contract.** The new plan under contract will cover an estimated potentially eligible eight hundred (800) judges who would participate on a voluntary basis.

Term of Award

A single estimated quantity term contract will be awarded for an initial term of three (3) years effective on or about June 1, 2007. The UCS reserves the right to renew the contract for two (2) additional one-year (1) periods upon the same terms and conditions, except rates. The contract and its renewal will be subject to the approval of the NYS Office of the Comptroller.

Pricing/Rates

Bidder shall underwrite this plan without the payment of commissions.

Term Life rate shall be quoted monthly per enrollee based on,\$1,000 of benefit coverage.

Bidders should assume the following:

- a. OCA/JBO to certify eligibility.
- b. Contractor to pay claims based on plan provisions as stated in the Plan.

Bidder shall guarantee rates for at least two years. For the subsequent contract years, including the renewal period, bidder shall define how premium rates will be determined and indicate any guaranteed caps for price increases.

Deviations from Specifications

Bidder shall confirm that its proposal conforms in all respects with all the terms of this RFP OCA/JB-120. Bidder shall identify specifically the provisions of its proposal that would deviate from the terms of this RFP and indicate the cost implications of the deviations if any.

Method of Award

A single contract shall be awarded to the bidder scoring the **highest point total** for the following criteria:

1. Financial Offering defined as Lowest Dollar Cost per plan. 50 points

The lowest dollar cost for each plan shall receive 50 points.

The points awarded to bidders other than the lowest dollar bidder will be a fraction of the maximum points to be calculated according to the following formula:

Lowest dollar cost divided by second/third/etc. cost multiplied by maximum points (i.e., 50) equal the number of points for the second, third, etc. bidders.

Example: Lowest dollar cost = \$100 = 50 points (maximum)

Second lowest dollar cost = \$125
\$100 divided by \$125 = .80 x 50 = 40 points

For purposes of the method of award, points for Plan #1 and Plan #2 will be considered separately.

2. Service facilities for claim administration and member support services, client reports, systems and data transmission capability, financial and claim controls. 20 points
3. Conformance with the specifications of this RFP 15 points
4. Overall financial and organizational resources and experience 15 points

The award shall be made to the bidder accumulating the highest point total.

In addition to the evaluation criteria set forth above, consideration will be given to the bidder's responsibility. Bidder shall be defined as responsible in accordance with, but not limited to, compliance with this RFP's specifications, references, past performance history, financial stability and any other criteria necessary and reasonable to establish the bidder's responsibility, including ratings by the New York State Insurance Department of company's ability to pay claims.

Evaluation Committee

An evaluation committee of four members will be set up to analyze bid proposals. It will include two managers from the JBO and two representatives from OCA Contract Administration. Bid proposals will be submitted to USI New York for its comments. USI New York, as a consultant who provided advice on drafting these specifications, is barred from bidding on this solicitation.

Supporting Presentation

The OCA/JBO may request bidder to make an oral and visual presentation(s), on an individual basis, in support of its proposal.

Billing

The awarded contractor shall submit invoices on a monthly basis and, upon the OCA/JBO's approval of the invoices, shall be paid in arrears.

Qualifications

Bidder shall provide an organizational chart identifying the names and titles of the Account Manager and team members who will be responsible for the Unified Court System's account. Bidder shall also provide a resume and copies of diplomas/state certifications/other qualifications for each identified team member including the Account Manager. The Account Manager's business address, phone and fax numbers as well as e-mail address should be provided. Subcontracting

Subcontracting shall not be allowed without the prior written approval of the Office of Court Administration/Judiciary Benefits Office.

Subcontracting of any services described herein, if approved by OCA/JBO, shall be subject to the following:

1. Bidder must identify in its proposal each proposed subcontractor, type of service(s) to be performed, length and nature of bidder's relationship with proposed subcontractor and must provide any and all additional information regarding the proposed subcontractor as UCS considers reasonable and necessary.
2. All proposed subcontractors shall be subject to the approval of OCA/JBO prior to engagement by contractor and any such approved subcontractor shall be held to the same performance standards as awarded contractor.
3. The UCS, OCA/JBO will communicate only with awarded contractor and the awarded contractor shall remain wholly liable for the performance of any such subcontractor, its employees, agents, consultants or representatives.

Independent Contractor Status

It is expressly understood and agreed that the awarded contractor's status shall be that of an independent provider of services and that no officer, employee, servant or subcontractor of the contractor is an employee of the UCS, OCA or State of New York.

Liability Insurance

Bidder must include with its response evidence of both professional and general liability insurance coverage from a carrier authorized to do business in New York State in the minimum amount of \$1,000,000 for each occurrence. A copy of the Certificate of Insurance issued by bidder's carrier will be sufficient proof.

Compliance with Law

Financial Stability

Termination

****** DETAILED SPECIFICATIONS ******

Background

The New York State Unified Court System, Office of Court Administration, is seeking to obtain a group term coverage to provide an additional, flat \$1,000,000 term life policy (or the highest maximum that bidders can propose) for its retirement-eligible judges only who are choosing to remain actively at work. These retirement-eligible judges are between the ages of 55 and 76 and must have at least five (5) years of retirement eligible service credit.

Currently these judges have life insurance coverage under a Unum Provident policy. The policy is a flat \$50,000 benefit which reduces to \$25,000 at age 65, \$20,000 at age 70 and \$15,000 for all retirees regardless of age. These retirement-eligible judges are also covered by a death benefit policy provided through the New York State retirement system that will pay their beneficiary three times (3x) their salary should they die while they are still actively at work. However, because these judges are choosing to remain actively at work even after they become retirement-eligible, if they die while they are actively at work there is no continuation of pension for their surviving spouse.

All retirement-eligible judges who are actively at work would be eligible for the term life insurance coverage, regardless of age or physical condition, but no judge would be required to participate in either plan. The full benefit will be guarantee issue.

This benefit will be paid for by UCS but each judge has the option to decline coverage.

Plans

Bidders may bid on either Plan #1 or Plan #2 or may bid on both plans.

The Office of Court Administration is requesting bidders to provide two different plan designs. With the exception of the age reduction schedule, the plans should be identical.

Plan #1: Plan #1 would have no age reductions but the benefits would end when the judge retires from active work. All judges must retire by the conclusion of the calendar year in which the judge turns 70 or, for those indicated on Exhibit 1 as Sup Ct Jus or Act Sup Ct Jus, by the conclusion of the calendar year in which the judge turns 76.

Plan #2: The benefit under Plan #2 would have the most aggressive age reduction schedule that the bidder can offer and it would end when the judge retires from active work. All judges must retire by the conclusion of the calendar year in which the judge turns 70 or, for those indicated on
