DISTINGUISHING FEATURES OF WORK:

Chief Clerks are the highest ranking nonjudicial employees in Supreme and County, City, Family, and Surrogate's Courts. Chief Clerk III are responsible to Judge(s), regional court administrators, and the Office of Court Administration for managing all aspects of court operations and nonjudicial case processing activities. Chief Clerk III serve in a confidential capacity and supervise subordinate personnel, allocate court resources, prepare annual budget requests, make employee selection decisions, and are responsible for the receipt, accounting and disbursement of fines, bail fees, and other public or custodial funds. Chief Clerk III also perform other related duties.

ASSIGNMENT:

Duties include responsibility for the day to day operations of the court; personnel management, budget preparation, strategic planning, operational planning, records management, database management and logistics; supervision and training of non-judicial staff; reviewing workload and staffing assignments and making adjustments; meeting with staff to ensure compliance with rules, policies, and procedures; completing performance evaluations; interviewing and hiring new employees; handling unusual and complex case file issues; and interacting regularly with Judges, attorneys and court users.
