Counsel are required to attend on the return date unless the Court is notified by the close of business the day prior to the return date that the motion is withdrawn, resolved, a proposed Order is to be submitted or you receive permission from the Court to submit on the papers. Failure to appear, except as noted above, may result in the imposition of sanctions pursuant to 22 NYCRR Subpart 130-2.

Please note that the Preliminary Conference has to be scheduled within 45 days of the filing of the RJI. If you anticipate scheduling problems, please refer to the Order Setting Preliminary Conference, Page 3.
