Upon the Information, inspection reports and all prior proceedings herein, including information provided to the Court on 9/1/2009, it is hereby

**ORDERED**, that the City of Buffalo shall board up or secure the building located at **ADDRESS OF PROPERTY**, within 30 days of the date of this Order; and it is further

**ORDERED**, that the City of Buffalo shall stencil a notice on the board covering the front entrance to that building, stating: "**ORDER TO VACATE – IF YOU ARE FOUND ON THIS PROPERTY, YOU MAY BE REMOVED IMMEDIATELY BY THE BUFFALO POLICE DEPARTMENT, ARRESTED AND CHARGED WITH CRIMINAL CONTEMPT IN THE SECOND DEGREE IN VIOLATION OF PENAL LAW § 215.50(3), WHICH MAY**

**RESULT IN YOUR INCARCERATION FOR UP TO ONE YEAR AND/OR A \$1,000 FINE**"; and is further

**ORDERED**, that the BUFFALO POLICE DEPARTMENT may use any and all means necessary to enforce this Order, including but not limited to breaking down doors or other barriers in order to gain access into any building; and it is further

**ORDERED**, that any individual subsequently found on such property (other than those listed above or in the yard performing routine lawn maintenance or the removal of debris, snow and ice) may be charged with criminal contempt in the second degree in violation of Penal Law § 215.50(3), by resisting this mandate of the court.
