An appeal having been taken to this Court in Action No. 1 by plaintiff, Anthony Newell, from an order of the Supreme Court, Bronx County, entered on or about June 7, 2018, which granted the motion of defendant Bronston and the cross motion of defendant Javier for summary judgment, and said appeal having been perfected,

And an appeal having been taken to this Court in Action No. 1 by defendant Bronston, served and filed by her attorneys as plaintiff in Action No. 2, from the aforesaid order of the Supreme Court, Bronx County, entered on or about June 7, 2018, insofar as it granted defendant Javier's motion for summary judgment,

Plaintiff-appellant Newell, if so advised, shall be permitted to file a reply brief on or before March 6, 2020, for said Term.
