

**DIRECTIONS TO THE APPELLATE TERM

**FROM MANHATTAN / WESTCHESTER / NEW JERSEY:**

Take the FDR Drive South or the West Side Highway South to the Brooklyn Bridge. Proceed straight off the bridge onto Adams Street which becomes Boerum Place. Take Adams Street/Boerum Place five lights to Livingston Street. Make a left on Livingston Street and proceed one block to 141 Livingston Street (corner of Smith Street).

**FROM QUEENS / LONG ISLAND:**

Take the Brooklyn-Queens Expressway South to the Tillary Street exit. Proceed on Tillary Street to Adams Street. Make a left onto Adams Street which becomes Boerum Place. Take Adams Street/Boerum Place five lights to Livingston Street. Make a left on Livingston Street and proceed one block to 141 Livingston Street (corner of Smith Street).

**FROM STATEN ISLAND / NEW JERSEY:**

Take the Verrazano Bridge and follow signs for I-278 into the Brooklyn-Queens Expressway North. Exit at Atlantic Avenue, bearing right at the fork. Proceed 5 lights to Boerum Place. Turn left onto Boerum Place and proceed 3 lights to Livingston Street. Make a right on Livingston Street and proceed one block to 141 Livingston Street (corner of Smith Street).

**FROM EASTERN LONG ISLAND:**

Take the Belt Parkway West into the Gowanus Expressway. Proceed to the Brooklyn-Queens Expressway North. Exit at Atlantic Avenue, bearing right at the fork. Proceed 5 lights to Boerum Place. Turn left onto Boerum Place and proceed 3 lights to Livingston Street. Make a right on Livingston Street and proceed one block to 141 Livingston Street (corner of Smith Street).

**BY SUBWAY:**

#1, 2, 4, 5 to Boro Hall  
M, R to Court Street  
A, F to Jay Street / Boro Hall

### **FROM BROOKLYN, STATEN ISLAND & LONG ISLAND:**

Take the Belt Parkway to the Van Wyck Expressway,

Exit at Jamaica Avenue.

Turn right on Jamaica Avenue to Sutphin Boulevard,

Turn left on Sutphin Boulevard to Hillside Avenue,

The courthouse will be on the right side.

### **FROM QUEENS & LONG ISLAND:**

Take the Long Island Expressway to the Grand Central Parkway to the Van Wyck Expressway,

Exit at Hillside Avenue.

Turn left onto Hillside Avenue and proceed to Sutphin Boulevard,

Turn right on Sutphin Boulevard,

The courthouse will be on the left side.

**BY SUBWAY:** E, F, J. or LIRR to Sutphin Boulevard.

**FROM THE VERRAZANO NARROWS BRIDGE:**

Take the lower level of the Verrazano Narrows Bridge.

Take the exit toward Bay Street.

Stay straight to go onto School Road.

Turn left onto Bay Street. Bay Street becomes Richmond Terrace.

Turn left onto Schuyler Street.

Turn left onto Stuyvesant Place.

126 Stuyvesant Place will be on your left.

**MINEOLA:**

Supreme Court Building

100 Supreme Court Drive, Mineola, NY

**FROM BROOKLYN & STATEN ISLAND:**

Take the Belt Parkway Eastbound to the Southern State Parkway to the Meadowbrook Parkway North,

Exit at Old Country Road – exit M1

Turn left onto Old Country Road

Turn left onto Washington Avenue and proceed two lights

The courthouse will be on your right.

**FROM QUEENS & UPSTATE:**

Take the Grand Central Parkway to the Meadowbrook Parkway South,

Exit at Old Country Road – exit M1

Turn right onto Old Country Road

Turn left onto Washington Avenue and proceed two lights

The courthouse will be on your right.

**BY TRAIN:** LIRR to Mineola Station. Walk 1 block south to Old Country Road, walk left two blocks to County Court Drive, make a right and walk to Supreme Court Drive.

**CENTRAL ISLIP:**

Cohalan Court Complex  
400 Carleton Avenue  
Central Islip, NY

**EASTBOUND OR WESTBOUND:**

Take the Long Island Expressway to Exit 56 South (Route 111),  
Proceed approximately one block.  
Bear left at the fork onto Wheeler Road.  
Continue on Wheeler Road which will turn into Carleton Avenue at the railroad  
tracks.  
Continue on Carleton Avenue (approximately six traffic lights) until you see the  
Cohalan Court Complex on your left.

**SOUTHERN STATE PARKWAY (EASTBOUND):**

Take the Southern State Parkway to Exit 43A.  
Exit parkway and make right onto Spur Drive North.  
Make right onto Carleton Avenue.  
Make first right into the Cohalan Court Complex.

**SOUTHERN STATE PARKWAY (WESTBOUND):**

Take the Southern State Parkway to Exit 43A.  
Cross over Spur Drive North.  
Go past the Federal Courthouse Building and follow signs to the Cohalan Court  
Complex.

**WHITE PLAINS:**

The Westchester County Courthouse  
Courthouse Square  
140 Grand Street, 6<sup>th</sup> Floor, White Plains, NY

**FROM WESTCHESTER & ROCKLAND COUNTIES & UPSTATE NY:**

Take the NYS Thruway to Exit 8  
Take the Cross Westchester Expressway (also known as Rt. 287) East to Exit 6  
Turn right at North Broadway (Route 22) to Martine Avenue  
Turn left onto Mamaroneck Avenue  
Turn right onto Quarropas Avenue  
Turn left onto Grand Street  
The building will be on your right.

**FROM THE SOUTH:**

Take the Triboro Bridge to Bruckner Expressway North to the Bronx River  
Parkway to Exit 21 White Plains – Main Street  
Turn right onto Main Street  
Turn right onto Lexington Avenue  
Turn left onto Quarropas Avenue  
Turn right onto Grand Street  
The building will be on your right.

**BY TRAIN:** Metro North Harlem Line to White Plains Station.

**GOSHEN:**

Take the Tappan Zee Bridge onto NYS Thruway North to Exit 16 – Harriman

After the toll booth take 17W/6W to exit 124 – Goshen

Proceed to the end of the ramp and turn left at the traffic light

At the next traffic light turn right onto Route 207

Proceed straight for 1-1 ½ miles through the Village of Goshen

The Government Center will be on the left side.

**BY BUS:** From Port Authority take the Short Line Bus to Goshen.

Take the Taconic State Parkway North to the Poughkeepsie Rte 55 exit  
(do not take the Poughkeepsie Rte 44 exit)  
Stay on Route 55 for approximately 10-15 miles, it becomes the East-West  
Arterial and eventually turns into Mill Street  
At the intersection of Mill Street and Civil Center Plaza you will see the Grand  
Hotel  
Bear left after the hotel and make a left at the next traffic light  
The courthouse will be on your right.
