

INSTRUCTIONS FOR PLEADING GUILTY TO SUMMONS BY MAIL.

NOTICE: IF YOU DO NOT FOLLOW THESE INSTRUCTIONS A WARRANT MAY BE ORDERED FOR YOUR ARREST.

TO PLEAD NOT GUILTY: You must come to Court at the place and time shown on the front of your summons.

TO PLEAD GUILTY: You must come to Court at the place and time shown on the front of your summons. However, if you are charged with Public Consumption of Alcohol, or Public Urination, you may plead Guilty by mail. If you plead Guilty by mail you do not have to come to Court.

- To plead Guilty by mail (to one of the above two charges only):

 Complete and sign the Guilty Plea By Mail Form below.

 Prepare a check or money order payable to NYC Criminal Court for \$25 for Public Consumption of Alcohol or \$50 for Public Urination.
- Write the summons number on the check or money order.

DO NOT SEND CASH.
