

**ILLEGAL POSSESSION OF A  
VEHICLE IDENTIFICATION NUMBER  
(E Felony)  
PENAL LAW 170.70(1)  
(Committed on or after Nov. 1, 2002)**

The \_\_\_\_\_ count is Illegal Possession of a Vehicle Identification Number.

Under our law, a person is guilty of Illegal Possession of a Vehicle Identification Number when he or she knowingly possesses a vehicle identification number label, sticker or plate which has been removed from the vehicle or vehicle part to which such label, sticker or plate was affixed by the manufacturer in accordance with law.<sup>1</sup>

Under our law, with certain exceptions not applicable here, when a manufacturer affixes a label, sticker or plate to a vehicle or vehicle part, the manufacturer does so in accordance with law.

Some of the terms used in this definition have their own special meaning in our law. I will now give you the meaning of the following terms: "possess," and "knowingly."

POSSESS means to have physical possession or otherwise to exercise dominion or control over tangible property.<sup>2</sup>

A person KNOWINGLY possesses a vehicle identification number label, sticker or plate when that person is aware that he

or she is in possession of a vehicle identification number label, sticker or plate.<sup>3</sup>

In order for you to find the defendant guilty of this crime, the People are required to prove, from all of the evidence in the case, beyond a reasonable doubt, each of the following two elements:

1. That on or about (date), in the county of (county), the defendant, (defendant's name), possessed a vehicle identification number label, sticker or plate which had been removed from the vehicle or vehicle part to which such label, sticker or plate was affixed by the manufacturer in accordance with law.
2. That the defendant did so knowingly.

Therefore, if you find that the People have proven beyond a reasonable doubt both of those elements, you must find the defendant guilty of the crime of Illegal Possession of a Vehicle Identification Number as charged in the \_\_\_\_\_ count.

On the other hand, if you find that the People have not proven beyond a reasonable doubt either one or both of those elements, you must find the defendant not guilty of the crime of Illegal Possession of a Vehicle Identification Number as charged in the \_\_\_\_\_ count.
