EIGHTH DISTRICT COMMITTEE RECENT DEVELOPMENTS

The Eighth Judicial District Committee has a lot to report since our last update, published in the September issue of the Bulletin. First, we wrapped up our Family Law Training Series at the end of September. The series, cosponsored with the Erie County Bar Association Volunteer Lawyers Project (VLP), consisted of training programs on divorce, non-parent custody petitions, and child support proceedings. Collectively, the attorneys who attended the sessions committed to handling a total of 65 pro bono matrimonial and family law cases in the coming year.

On October 27, the Committee cohosted with VLP a training program on "Handling Unemployment Insurance Hearings." The trainers were Marcella Seaburg-Brackett, Senior Administrative Law Judge at the Unemployment Insurance Appeal Board in Buffalo, and Tracey Covey, Esq., a labor law attorney and VLP volunteer. Twenty-three people

NEWS FROM THE SEVENTH DISTRICT COMMITTEE

Nineteen attorneys from Steuben County were honored at a reception held in celebration of National Pro Bono Week on October 30, 2009, at Sonora's Restaurant in Bath. The attorneys were recognized for volunteering their time to assist low-income clients through the Southern Tier Volunteer Lawyers Project, a program of Southern Tier Legal Services. The event was part of the first-ever National Pro Bono Week, established by the American Bar Association to recognize the important contributions of volunteer attorneys and to encourage more attorneys to volunteer. Southern Tier Legal Services and ProBonoNY joined in that celebration.

Hon. Henry J. Scudder, Presiding Justice of the Appellate Division, Fourth Department, and formerly Supreme Court Justice in Steuben County, congratulated

attended the training and each received two free CLE credits in exchange for a commitment represent pro bono at least one claimant who has been denied benefits in an appeal to the Board.

In related news, starting with the Family Law Training Series, VLP has been video recording all of its training programs, in hope of being approved by the New York CLE Board to award CLE credit to attorneys who check out the recorded training programs and materials for self-study. I am pleased to report that VLP was granted "Approval of Nontraditional Format" on December 4. This is significant for the Committee's recruiting efforts, as it will allow the recordings to be used for both group and individual CLE trainings throughout the District, most notably for attorneys in our rural areas who often find it extremely difficult to fulfill their CLE requirements because of the inconvenience of often having hours-long travel times to the locations of live CLE programs. Attorneys who view the recordings and obtain the printed materials will be eligible to receive free CLE credit if they agree to take a pro bono matter referred by the pro bono program serving their county.

the award recipients and presented certificates of appreciation provided by ProBonoNY. Hon. Marianne Furfure and Hon. Joseph Latham also attended the event.

Amy Christensen, Deputy Director of Southern Tier Legal Services and a member of the ProBonoNY Committee for the Seventh Judicial District, thanked the volunteer attorneys for their service and highlighted the impact of their efforts: "Your help has meant a victim of domestic violence could obtain a divorce from an abusive spouse . . . a terminally ill man could have piece of mind in his last days, because he knew his legal affairs were in order."

The American Bar Association described the National Pro Bono Week Celebration as "a coordinated national effort to showcase the great difference that pro bono attorneys make to the nation, its system of justice, its communities, and, most of all, to the clients they serve. The week was also dedicated to the quest for more pro bono volunteers to meet the ever-growing legal needs of this country's most vulnerable citizens." The local pro bono celebration was sponsored by Southern Tier Legal Services, a division of Legal

Hon. Paula L. Feroleto, Administrative Judge of the Eighth Judicial District and co-chair of the Committee.

Also during National Pro Bono Week, the Committee organized a mailing to Niagara County attorneys signed by Hon. Ralph A. Boniello, Hon. Frank Caruso, and Hon. Richard C. Kloch, Sr., which enclosed a roster of attorneys who accepted pro bono cases through Niagara County Legal Aid Society in 2008 and 2009, thanking them for their service and encouraging other Niagara County lawyers to join their ranks. The letter was followed up by an e-mail from Judge Feroleto which attached a pro bono registration form with a list of opportunities tailored to the needs and priorities of clients of Niagara County Legal Aid Society.

The Rockland Committee's kickoff event was held on May 8, 2009, and distinguished guests, including Hon. Francis A. Nicolai (former Ninth District Administrative Judge), stressed the need for pro bono representation of local citizens, especially in today's troubled Many Rockland attorneys economy. answered the call by registering for the Volunteer Attorney Panel. The Rockland Committee's first training program was a four-CLE-credit guardian ad litem training program held October 14, in advance celebration of National Pro Bono Week. Judge Anthony Scarpino's popular program attracted over 75 participants. Cases to be handled pro bono by these volunteers are now being referred by the Legal Aid Society via the pro bono unit of Legal Services of the Hudson Valley.

The last week of October–National Pro Bono Week-was a busy one in the Ninth Judicial District. The committees in Westchester, Orange, and Dutchess Counties all held celebratory events during that week, proudly cooperating with county bar associations and other legal organizations as co-sponsors. Dutchess County, the events were held on October 27. The day started out with committee members greeting attorneys in the lobby of the Dutchess County Courthouse, providing them with the opportunity to register then and there for our volunteer attorney panel. This was followed by an afternoon three-credit CLE program on "Matrimonial Nuts and Bolts," with special emphasis on the view from the bench and a domestic violence perspective. Many attorneys commented on the eye-opening information they received on how to identify and help domestic violence victims, declaring their appreciation for valuable insights on how to handle such cases. The day culminated in a "Partners in Justice" reception, recognizing a local attorney and a paralegal for their devotion to pro bono clients and public service.

On October 28, the day started in Orange County with a breakfast meet-

and-greet event at the Orange County Courthouse. This was followed by a CLE program on child support issues. In the evening, a festive "Partners in Justice" reception was held at a local restaurant. The Committee was particularly pleased that Hon. Fern A. Fisher was able to attend this standing-room-only event. The Orange County Committee is fortunate in having strong support from many local law firms, and several firms as well as a number of solo practitioners were recognized for their extensive pro bono services.

The week's activities culminated on October 29 in Westchester County. A morning courthouse meet-and-greet event was followed by an afternoon CLE program held at Pace University Law School, on a topic especially relevant to the day: "Responding to the Needs of Westchester: Pro Bono Opportunities and Ethical Considerations." A Pro Bono Expo, sponsored in conjunction with the Westchester Women's Bar Association, was held in the entrance atrium of the Judicial Institute after the CLE program. Representatives of local legal service providers and community and student organizations were on hand to distribute information and recruit volunteers. This

event was especially popular with recent law school graduates looking for opportunities to get started while also serving the public good, as well as more seasoned attorneys considering new practice areas for pro bono service.

The grand finale to Pro Bono Week in the Ninth Judicial District was the "Partners in Justice" evening reception at the Judicial Institute, attended by many local dignitaries, including judges, the Westchester County District Attorney, and several local legislators. Plaques were presented to local attorneys and law firms for their pro bono contributions in helping clients, especially in the areas of landlord/tenant matters, bankruptcy, and unemployment insurance benefits. A special award went to Hon. Francis A. Nicolai, who, as former Ninth District Administrative Judge, was the leader in forming and inspiring our ProBonoNY Local Action Committees.
