POSITION TITLE: SENIOR LAN ADMINISTRATOR JG - 23

BASE SALARY: \$74,478

QUALIFICATIONS: Certification in Network Administration within eighteen (18) months of appointment; and One year of

Senior Local Area Administrators coordinate the responsibilities of local area network administrators, resolve problems with the implementation, operation, and maintenance of communication media, computer equipment, and network design, and perform other related duties.
