

Overview

The *Division of Technology & Court Research* (DoTCR) created the Detained Pretrial Monthly Extract in response to [Section 216 Additional duties of the chief administrator, Chapter 30, Article 7-a](#), requiring the Unified Court System (UCS) to compile and publish data on pretrial commitments to local correctional facilities. The de-identified data is available in a downloadable format on the UCS public website.

Population

Included in the extract are individuals detained pretrial in [Rikers Island Correctional Facility](#) in NYC at any point during the reporting month, beginning in January 2024. A new month's data will be appended to the extract at some point during the first half of the following month and will contain information on all individuals detained at any time during the previous month. Each row is a distinct individual within the reporting month. The extract is sorted where the most recent Year-Month period is at the top and within that Year-Month period, the individual with the earliest Admission Date on top.

Upon receipt of additional data, this website will be updated.

The extract only includes individuals with a detained Admission Reason:

- DETAINED FOR ANOTHER NEW YORK STATE COUNTY
- DETAINED, CIVIL OFFENSE
- DETAINED, FEDERAL INMATE, OTHER THAN CODES 45-46
- DETAINED, FELONY CHARGE
- DETAINED, MISDEMEANOR CHARGE
- DETAINED, OTHER
- DETAINED, OTHER CHARGE
- DETAINED, STATE INMATE, OTHER THAN FOR CODES 42-43
- DETAINED, SUPERIOR COURT ARREST OR BENCH WARRANT
- DETAINED, VIOLATION CHARGE
- DETAINED, VIOLATION OF PROBATION

Data Source

The data is compiled from a daily data feed from the Department of Corrections containing the roster of individuals held in Rikers that day. The extract provides the information recorded on the last day the individual was held in the reporting month, which could be the last day of the month or the date discharged. This is to ensure that each row is a unique person as different demographics can be recorded for a single individual on different days. If the individual was detained in Rikers and released and then detained again within the month, the extract shows information from the latest admission to Rikers.

Fields and Descriptions

1. **Row #** – row number that represents a distinct individual within the reporting month
 - a. A distinct individual will have different row numbers for each month incarcerated.
 - b. A distinct individual will not have the same row number(s) when the extract is updated because the new month will be sorted at the top.
2. **Year-Month** – reporting time period, sorted in descending order with latest Year-Month at the top
3. **Latest Admission Date** – the last time the individual was admitted to Rikers in the reporting month
4. **Latest Discharge Date** – date the individual was discharged if the individual was discharged during the reporting month
 - a. Blank if individual is still held at the end of the month
5. **Days From Latest Admission Date** – number of days held in Rikers as of the end of the reporting month
 - a. Admission Date to Discharge Date if individual was discharged during the reporting month
 - b. Admission Date to Last Day of Reporting Month if individual was still held at the end of the reporting month
6. **Months From Latest Admission Date** – logic for #5 divided by 30, rounded down
7. **Years From Latest Admission Date** – logic for #5 divided by 365, rounded down
8. **Age at Admission** – number of days from individual's Date of Birth to Admission Date, divided by 365 and rounded down
9. **Current Inmate Age** – age of individual recorded in DOC file on the last day held in Rikers during the reporting month
10. **Race** – race of individual recorded in DOC file on the last day held in Rikers during the reporting month
 - a. Values: *American Indian or Alaskan Native, Asian or Pacific Islander, Black, Other, Unknown, White*
11. **Gender** – gender of individual recorded in DOC file on the last day held in Rikers during the reporting month
 - a. Values: *F, M, U*
12. **Ethnicity** – Hispanic Y/N recorded in DOC file on the last day held in Rikers during the reporting month

a. Values: *H, N, U*

13. **Jailed on a Felony Charge** – *Y* if admission reason is DETAINED, FELONY CHARGE; *N* if other admission reason
14. **Jailed on a Misdemeanor Charge** – *Y* if admission reason is DETAINED, MISDEMEANOR CHARGE; *N* if other admission reason
15. **Jailed Other Reason** – *Y* if admission reason a reason on the list of [detained admission reasons](#) that is not DETAINED, FELONY CHARGE or DETAINED, MISDEMEANOR CHARGE; *N* if admission reason is DETAINED, FELONY CHARGE or DETAINED, MISDEMEANOR CHARGE
