This application for coordination comes to the Litigation Coordinating Panel at the request of Justice Ann Marie Taddeo of the Seventh Judicial District, who is presiding over the above captioned case filed in the Supreme Court of Monroe County. This case and six other cases were filed in the Supreme Court, four in Erie County and two in Bronx County, which are listed in the Appendix. All of these seven tort cases arise from a common motor vehicle collision between a tractor-trailer truck and a passenger bus on Route 81 South of Syracuse, New York on November 6, 2014.

After Justice Taddeo consulted with counsel for the plaintiffs and the defendants, it appears that in order to streamline the discovery and limit the number of depositions of the same defendants, other parties and relevant witnesses, there is an overwhelming consensus by the attorneys that these seven case should be coordinated before one Supreme Court Justice appointed to coordinate the discovery, pre-trial motions and settlement negotiations pursuant to the Unified Rules for Trial Courts Section 202.69.

The Panel is in receipt of a letter objecting to coordination dated February 12, 2018 from Kenneth Joelson, Esq. of New York County, who represents one of the two Bronx plaintiffs, Dionne Wyatt versus eight defendants in a case he filed in 2015. Unfortunately, that case has been apparently protracted by motion practice, whereby depositions have not been completed. Since no Note of Issue has been filed and it is otherwise not ready for trial, that case will be joined with the other six cases, which will be coordinated before one Justice for all pre-trial discovery, motions and settlement conferences. However, at the option of any plaintiffs' counsel, their case may be returned for trial to the county where it was originally filed, unless it is otherwise resolved. Also, at the plaintiff's option with the consent of the coordinating Justice any case not originally filed in the county of coordination may remain in the county where all of the cases are coordinated for trial.

The Panel, now having considered all of the issues with respect to this Application, including judicial economy, finds that the purposes of Uniform Civil Rules § 202.69 are best

served by granting coordination, with the overwhelming consent of most of the plaintiffs' and most of the defendants' counsel.

The Panel members, having deliberated on this application, have decided that since four of the seven cases are pending in the Erie County Supreme Court, all seven of the currently filed cases and any other cases which may hereafter be filed arising from this same accident shall likewise be coordinated in the Supreme Court of Erie County.

Accordingly, and upon due deliberation, it is hereby:

ORDERED, that the actions set forth above and in the appendix shall be Coordinated pursuant to the Uniform Civil Rules § 202.69 before a Coordinating Justice of Erie county; and it is further

ORDERED, that any actions that allege similar causes of action against the Defendants, that were filed in a Supreme Court of the State of New York, and which remain active, but are not listed in the above caption or the appendix, and any such actions that are filed hereafter shall likewise be Coordinated pursuant to the Uniform Civil Rules § 202.69 in the Supreme Court of Erie County, before a Coordinating Justice of that county; and it is further

ORDERED, that pursuant to the Uniform Civil Rules § 202.69(c)(1) of the State of New York, the Honorable Paula L. Feroleto, the Administrative Judge of the Eighth Judicial District which encompasses the Supreme Court of Erie County, shall assign the Coordinating Justice; and it is further

ORDERED, that the Clerk of the Panel shall forthwith transmit a copy of this Decision and Order to counsel for all parties herein, the Justices currently assigned in each of the seven actions, the Honorable Paula L. Feroleto, the Administrative Judge of the Eighth Judicial District and the Clerks of the Supreme Court of Bronx County, Erie County and Monroe County; and it is further

ORDERED, that within 15 days of receipt of a copy of this Order, the Clerks of the Supreme Court for Bronx County and Monroe County are directed to transmit the files in the listed actions that are pending in said counties to the Clerk of the Supreme Court of Erie County; and it is further

ORDERED, that with respect to any additional action that is to be Coordinated as provided in the second ordered provision hereof, upon service of a copy of the Decision and Order of the Panel with notice of entry, together with the affidavit of compliance or the decision of the Panel, upon the Clerk of the Court in which any such additional action is or hereafter shall be pending (other than the Supreme Court, County of Erie), said Clerk shall forthwith transfer to the Supreme Court, County of Erie, after the payment of appropriate fees, if any, the file in any such additional action that is to be Coordinated as provided in the Decision and Order in compliance with the Uniform Civil Rules § 202.69; and it is further

ORDERED, that the Clerk of the Supreme Court, County of Erie, shall assign an Erie County index number, without fee, to any such action transferred to that County from another County as provided above and such number shall serve as a means of identification and orderly processing of any such case while it remains in the County of Erie for the purpose of Coordination of pre-trial matters; and it is further

ORDERED, that coordination is for the purpose of pre-trial discovery, pre-trial and summary judgment motions and settlement conferences; and it is further

ORDERED, that after discovery is complete and after a Note of Issue is filed with a Certificate of Readiness for Trial, and after any motions for summary judgement are decided, then, in the event a final disposition of any case cannot be resolved, at the option of any plaintiff, their case may be remitted to the Supreme Court of the county wherein it was originally filed; and it is further

ORDERED, that in the event that any plaintiff whose case was not originally filed in the Supreme Court of Erie County, chooses to have their case tried in Erie County as opposed to the county where their case was originally filed, then in that event the Coordinating Judge must approve of the case remaining in Erie County for trial, or it shall be remitted back to the county from which it was originally filed.

This constitutes the Order of the Panel. The Panel, by its Presiding Justice and with their consent, signs this Order.
