DECISION AND ORDER

The plaintiffs in the action captioned above, moved the Litigation Coordinating Panel (the "Panel") for an order pursuant to Section 202.69 of the Uniform Rules for the Trial Courts, coordinating the action with 45 other State Supreme Court actions presently pending in various judicial districts, all of which allege claims for personal injury stemming from the ingestion of medications used in Hormone Replacement Therapy and some of which cases have already been assigned to Supreme Court Justices in their respective districts. The "joint application" by the Ashkin Law Firm and The Calwell Practice LLC is brought on behalf of the plaintiffs in the coordination motion by the Ashkin Law Firm.

The responding defendants have indicated <u>no</u> opposition to the motion, except as set forth in the affirmation submitted on behalf of the "Wyeth defendants," in which the defendants oppose the characterization of the actions by the plaintiffs. The defendants however do not oppose the coordination of the actions and include a request to coordinate <u>eight</u> other matters not identified in the plaintiff's coordination motion.

The "Pfizer Inc., Pharmacia Corporation, Pharmacia & Upjohn LLC and Greenstone Ltd. Defendants" also request <u>two</u> additional cases not identified in either the plaintiff's or the "Wyeth Defendant's" list of matters be coordinated; they do not oppose the coordination of these matters.

The Panel having met and considered the issues and circumstances involved, concluded that the application should be granted and also include all pending matters and those that may hereafter be filed. Coordination shall take place in the County of New York before a Justice of that county to be designated by the Administrative Judge thereof.

For these reasons, it is hereby

- (1) Ordered that the actions set forth above and in the Appendix shall be coordinated pursuant to Section 202. 69 of the Uniform Rules of the Trial Courts, in the Supreme Court of the State of New York, County of New York, before a Coordinating Justice of that county; and it is further
- (2) Ordered that any actions for personal injury alleged to have occurred as a result of the ingestion of medications in the course of Hormone Replacement Therapy and that were filed in the Supreme Court of the State of New York heretofore and that remain active but that are not listed in the caption above or on the attached Appendix and any such actions that are filed hereafter shall, in accordance with Subdivision F of the Procedures of the Panel, likewise be coordinated pursuant to Section 202.69 of the Uniform Rules of the Trial Courts of the State of New York before the said Coordinating Justice unless the Panel rules otherwise as provided in said Subdivision F: and it is further
- (3) Ordered that, pursuant to Section 202.69(c)(1), the Administrative Judge of the First Judicial District shall designate the Coordinating Justice: and it is further
- (4) Ordered that the Clerk of the Panel shall forthwith transmit a copy of this Decision and Order to counsel for all parties herein, the Justices to whom each of the above actions is currently assigned, and to the Honorable Jacqueline W. Silbermann, Administrative Judge of the First Judicial District; and it is further
- (5) Ordered that, with respect to any additional action that is to be coordinated as provided in Paragraph (2) hereof, upon service of a copy of the Decision and Order of the Panel with notice of entry, together with either the affidavit of compliance or the further decision of the Panel set forth in Subdivision F of the Procedures of the Panel, upon the Clerk of the Court in which any such action is or hereafter shall be pending (other than the Supreme Court of New York County) as provided in Subdivision F, the said Clerk shall forthwith transfer to the Clerk of the Supreme Court, New York County, after payment of appropriate fees, if any, the file in any

such additional action that is to be coordinated as provided in this Decision and Order and Subdivision F: and it is further

(6) Ordered that, the Clerk of the Supreme Court, New York County, shall assign a New York County index number without fee to any action transferred to that County from another as provided above and such number shall serve as a means of identification and orderly processing of any such case while it remains in New York County for the purpose of coordination.

This constitutes the Decision and Order of the Panel. The Presiding Justice of the Panel signs this Decision and Order on her own behalf and with the authorization and on behalf of all of the other members of the Panel.
