

**ADMINISTRATIVE ORDER OF THE
CHIEF ADMINISTRATIVE JUDGE OF THE COURTS**


Pursuant to the authority vested in me, and with the consultation and agreement of the Honorable Elizabeth A. Garry, on behalf of the Appellate Division, Third Department, I establish the following regular terms, parts and hours of court for the Supreme, County, Surrogate's, Family, and City Courts in the Third, Fourth, and Sixth Judicial Districts for 2019, assign the Justices and Judges thereto, except for certificated Justices of the Supreme Court who have been assigned to terms and parts of court by the Appellate Division; and designate the terms of court for the impaneling of grand jurors. In addition, in consultation with the Appellate Division, I adopt the following administrative and calendar rules.

Unless otherwise specified, all assignments are made to Individual Assignment Parts for the 13 terms set forth above, and such parts are established for the determination of all actions as may come before the courts, including motions, trials and other proceedings in connection therewith. All inter-district assignments of Supreme Court Justices are to Supreme Court in the designated county. All courts shall be open for business Monday through Friday each week of the year, except for legal holidays. The legal holidays for 2019 are as follows:

Grand jurors shall be summoned to appear on the opening day of the terms so designated and shall continue until the day preceding the commencement of the next succeeding grand jury term, unless otherwise specified herein or directed by the Justice or Judge presiding at such term.

The District Administrative Judge may establish local calendar rules consistent with the Rules of the Chief Administrator for the timely administration of justice.
