

Finding Cases When you have a Case Citation

Note: Lexis Advance and Westlaw legal research services are illustrated below.

Overview

In New York state, a case starts in a trial court. If one of the parties is dissatisfied, the case is appealed to an appellate court. If a party dislikes the appellate court's decisions, the case will be appealed to the highest court, the Court of Appeals. New York State has an official publisher, the Law Reporting Bureau, charged with the responsibility to:

report every cause determined in the court of appeals and every cause determined in the appellate divisions of the supreme court, unless otherwise directed by the court deciding the cause; and, in addition, any cause determined in any other court which the state reporter, with the approval of the court of appeals, considers worthy of being reported because of its usefulness as a precedent or its importance as a matter of public interest.

The Law Reporting Bureau publishes these three levels of court opinions in the following reporters:

West Publishing compiles all three levels of court opinions in the New York Supplement. The New York Law Journal, the legal newspaper for the First Department, selectively publishes trial court decisions of interest, appellate decisions of the First and Second Departments, and Court of Appeals decisions..

Since so many cases are published, reporters are issued in volumes. Usually, once 999 volumes have been issued for a reporter, a new series for that reporter is started. Reporters' titles are also abbreviated; see the chart below.

Once a case is published in a reporter, it is assigned a citation. A citation is a legal abbreviation format that assists accurate research reporting; it starts with the volume number of the reporter, the abbreviation for the reporter, and the opening page number of the case.




If you have a case name or citation, you can pull it up from the home page of either LexisAdvance or Westlaw.

Lexis Advance

After signing into Lexis Advance, type a citation in the query box. If you do not know the abbreviation for the reporter, click on Get A Doc Assistance



Since you want a citation abbreviation, you will select cases from the Get a Doc Assistance By Citation drop-down menu.



After selecting Cases, you select New York as your jurisdiction. A list of New York Reporters appears. Click on the blue abbreviation for a template to enter the volume and page numbers.
