An appeal is taken by filing, in the Clerk's office of the criminal court in which the order sought to be appealed was rendered, a written notice in duplicate that appellant appeals to the Appellate Division, First Judicial Department (CPL 460.10 [4]), together with proof that another copy of the notice of appeal has been served upon opposing counsel. The appeal (or consolidated
