ORDERED, that VERA SHAKAROVA, parent and natural guardian of the infant plaintiff, SHAKAROV, ELIZABETH, be and she hereby is authorized to settle the cause of action of the infant herein by complying with the following terms of this order, to wit:

ORDERED, that the defendant, THE CITY OF NEW YORK ANO THE NEW YORK CITY DEPARTMENT OF EDUCATION, and/or their insurance carrier, pay the sum of Forty Five Thousand Dollars (\$45,000.00) in full settlement of the infant, SHAKAROV, ELIZABETH, cause of action, and it is further,

ORDERED, that out of the said sum there be paid to WILLIAM SCHWITZER & ASSOCIATES, P.C. the attorneys for the plaintiffs, the sum of \$1,542.83 as and for compensation for their legal expenses and disbursements; and it is further,

ORDERED, that out of the said sum there be paid to WILLIAM SCHWITZER & ASSOCIATES, P.C. the attorneys for the plaintiffs, the sum of \$14,485.72 as and for compensation for their legal fees; and it is further,

ORDERED, that out of the said sum there be paid to MEDICAID, New York City Human Resources Administration, the sum of \$2,784.02 as and for satisfaction for their liens; and it is further,

ORDERED, the balance of said sum in the amount of 26,187.43 be paid to VERA SHAKAROVA, as parent and natural guardian of SHAKAROV, ELIZABETH, jointly with an officer of **CHASE BANK**

located at **10736 71st AVENUE FOREST HILLS, NY 11375**, and shall be deposited in a Time Deposit or Certificate of Deposit Account.

Said funds shall be deposited in the above bank in the name of the Mother, VERA SHAKAROVA, as natural guardian and held for the sole benefit of said infant in accounts paying the highest interest available, subject to the further order of this Court until the infant reaches the age of 18 years, and it is further,


ORDERED, that no withdrawal from this account shall be made unless it is by further order of this Court; and it is further

ORDERED, that upon presenting proof that the infant plaintiff has attained the age of eighteen (18) years, said bank shall release any and all funds in said account to SHAKAROV, ELIZABETH, without any further order of this court; and it is further

ORDERED, that a bond be dispensed with pursuant to Section 1210[c] of the CPLR and upon full compliance with the terms of the order, VERA SHAKAROVA, as parent and natural

guardian of the infant is authorized and empowered to execute a general release on behalf of the infant, SHAKAROV, ELIZABETH , to the defendant.

ORDERED, that pursuant to the Uniform Rules of New York State Trial Courts, Section 202.5, the attorneys and the client to this action have mutually agreed that the name of the infant-plaintiff, SHAKAROV, ELIZABETH, shall not be redacted.
