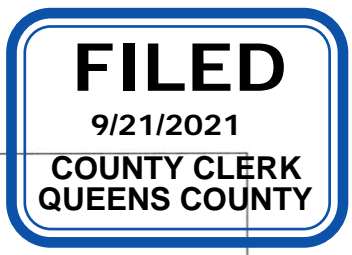

ORDER GRANTING AFFIRMATION IN APPLICATION FOR ITALIAN DUAL CITIZENSHIP

AND NOW, TO WIT, this 17th day of September 2021, upon consideration of the foregoing Petition for Order of Affirmation presented by Petitioner, Peter Magri, Jr., it is hereby ORDERED and DECREED that the name of Petitioner's Great-grandfather and Grandmother have changed over time through error and the desire of Petitioner's family members to be acclimated to the American culture. Petitioner's Great-grandfather ("Great-grandfather") named "Giambattista Tommasone" is the one and same person as "John Battista Tommasone" and "Giovanni Tommasini;" and Petitioner's Grandmother ("Grandmother") named "Vincenzina Tommasone" is the one and same person as "Vincenzina Tommasini" and "Virginia Tomasino."

It is further ordered that the Petitioner has presented the Court with sufficient proof to show that Petitioner's ancestry is as follows:

1. Petitioner's Great- grandfather was born "Giambattista Tommasone" on [REDACTED], 1886 in Venafro, Italy.
2. Petitioner's Great- grandfather immigrated to the United States.
3. On July 8, 1923, Petitioner's Great-grandfather married Maria Forchina in Queens County, New York.

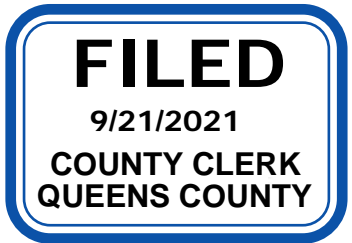
4. On [REDACTED] 1926, Petitioner's Great-grandparents had a daughter, Petitioner's grandmother, "Vincenzina Tommasone," in Queens County, New York.
5. Petitioner's Grandmother, Vincenzina Tommasone, married Michael L. Cappuccio on February 25, 1945 in Queens County, New York.
6. Petitioner's Grandparents had a daughter, Petitioner's Mother, Marie Elaine Cappuccio, on [REDACTED] 1945 in Queens County, New York.
7. On September 1, 1968, Petitioner's Mother married Peter Magri in Queens County, New York.
8. On [REDACTED], 1972, Petitioner's parents had a son, Petitioner.
9. No formal changes of name for Petitioner's Great-grandfather or Grandmother were ever made.

It is further ordered that a certified copy of this Order be submitted by Petitioner, Peter Magri, Jr., to the Citizenship Office of the Consulate General of Italy in for the purpose of having his Italian citizenship recognized.
