These were changes necessitated by LATFOR's determination that the enacted map technically violated the town-on-boarder rule at a couple of locations and also LATFOR's recommendations to facilitate the Board of Elections administration of the elections in a few districts. These proposed changes have been reviewed by Dr. Jonathan Cervas and the court and meet with the approval of both. Therefore, these changes will be made. The changes are attached as exhibit "A".

NOW, therefore, upon consideration of all papers and proceedings heretofore had herein, and after due deliberation, it is

ORDERED, ADJUDGED, and DECREED that the enclosed Exhibit "A" changes be made to the Congressional and Senate Maps enacted on May 20, 2022; and that as modified these become the final enacted redistricting maps.
